1) Trend of COVID-19 cases/positive COVID-19 tests

The seven-day average percent positive has decreased over the past week (12/1 to 12/8) from 13.5 to 12%. The seven-day average for cases per million has decreased from 743 to 505. These indicators are now both declining. Please note, as with last week, that this decline is relative to our major surge in the beginning/middle of November – our numbers are still quite high overall.

2) Hospitalizations due to COVID-19

Three at SIH in the past week. Please recall that, regardless, SIH is not a great indicator because they try to transfer COVID patients rather than admit them. Hospitalizations continue to be elevated compared to earlier in the year, but in most areas of the state numbers are plateauing or declining. Remember, as always, that hospital admission numbers can change rapidly.

3) Number of deaths resulting from COVID-19 in the past 14 days Sixteen for Ionia County

- 5) Percentage of positive COVID-19 tests over a four-week period Increased from 9 to 12% (seven-day average) from November 8th to December 8th.
- 6) Health Care capacity strength
 Nobody knows what this means because the legislature did not define it.
- 7) Testing, tracing, and containment infrastructure with regard to COVID-19

 The Health Department is now partnering with Helix Diagnostics to do drive-through testing at the Fairgrounds in Ionia. Turnaround time for Sparrow and Helix is around 48 hours. Contact tracing has been scaled up at the State level and we are doing better with case investigation. Containment infrastructure is weak. We have no way to know if most people are truly complying with quarantine and isolation. This is a problem across the State.

K-8 can remain open provided there is no active transmission in the building. For purposes of the matrix that was sent out, we are in Risk Category E as a County.
