Trend of COVID-19 cases/positive COVID-19 tests:

The seven-day average percent positive has increased over the past week (4/10 to 4/17) from 17.9% to 18.9%. The seven-day average for cases per million has decreased from 598 to 494. Please note that State data for cases per million are incomplete for 4/17 – this number will likely increase over the new few days.

Hospitalizations due to COVID-19:

One currently hospitalized at SIH. Please recall that hospitalization numbers can change rapidly.

Number of deaths resulting from COVID-19 in the past 14 days:

Two for Ionia County. Please recall that this is a lagging indicator.

COVID-19 cases for each day for every one million individuals:

Percentage of positive COVID-19 tests over a four-week period:

Increased from 2.9% to 18.9% (seven-day average) from March 17th to April 17th.

Health Care capacity strength:

Nobody knows what this means because the legislature did not define it.

Testing, tracing, and containment infrastructure with regard to COVID-19:

Demand for testing is steady. Turnaround time for PCR tests locally is between 24-48 hours. Tracing and Case Investigation is still a struggle as we perform mass vaccination at the same time as this surge with limited staffing. Containment infrastructure is weak.

Indicators statewide are plateauing or starting to decline. Ionia County is just starting to mirror these trends. K-12 can remain open provided there is no active transmission in the building. We are in Risk Category E as a County.
