Students riding the bus will:

- Use hand sanitizer upon boarding the bus

As weather permits, bus windows will remain open during operation and buses will be cleaned and disinfected after each run upon return to the bus garage.

- Non-staff, including volunteers & guests, will not be allowed in the school building beyond the school office
- Parents/guardians with specific school business (including picking up students during the school day) will be allowed in the school office and must wear a facial covering and complete a health screening form
- Students will move directly to their classroom upon arrival at school and be expected to directly exit the building at the end of the school day
- Student seating in classrooms will be spaced to the greatest extent possible
- To the extent possible, students will remain in classrooms and move throughout the building in ways that limit contact with other classes/groups of students [inclusive of breakfast, lunch, elementary specials classes, and secondary passing time]

## WHAT IN-PERSON LEARNING LOOKS LIKE **PHASE 4**

PHASE 4 – In person instruction is permitted with required safety protocols. "In-Person" instruction refers to teaching and learning that occurs in classrooms and other instructional spaces within the school building

#### **FACIAL COVERINGS REQUIRED**

We wear facial coverings not just because they are required, we wear them because we care about the well-being of students, teachers, friends, and family and expect them to care about our well-being.

- · At all times for staff
- At all times for 5-12 students
- At all times for preK-12 students while riding the bus
- At all times for K-4 students outside of their classrooms
- K-4 students may, and are encouraged to wear facial coverings in classrooms to the extent they are able.

Exceptions for anyone include:

- During meals
- Who cannot medically tolerate a facial covering
- Who is incapacitated or unable to remove the facial covering without assistance
- Staff or students who cannot medically tolerate a facial covering will be required to submit a Medically Vulnerable – Physician Form

#### REMOTE INSTRUCTION

The need to go to remote instruction last spring was sudden, new to many, and we learned a great deal. The Lakewood Public Schools is committed to offering a robust and rigorous remote program characterized by:

- Opportunities for face to face instruction and/or interaction between students and their assigned teachers occurs
- Students are taught by Lakewood Public Schools teachers using the Board of Education approved district curriculum (exceptions may include special interest or advanced courses for which enrollment is minimal and available from a third-party provider)
- Assignments normally provided in class or for homework, aligned to the daily learning targets, are given to and completed by students on a regular, if not daily basis
- Assessments, such as tests, papers, or projects, aligned to the unit learning targets, are given to and completed by students at the end of each curricular unit
- Every effort will be made to provide access to counseling services for personal and post-secondary support
- Coordination between general, special education teachers, and service providers will occur to support students' instructional and other needs as outlined in students' IEPs/504 plans, revising those plans as necessary
- Non-participation by students in instruction will be referred to the building principal for follow up with the student and his/her parent(s) to reengage the student in regular daily instruction

PARENTS WHO SELECT REMOTE INSTRUCTION FOR THEIR STUDENTS MAY ELECT TO RETURN TO IN-PERSON INSTRUCTION AT THE END OF EACH NINE-WEEK ACADEMIC QUARTER.
